## Who we spoke to

Lilydale town centre has a highly engaged and proud community who actively participated in a broad suite of engagement for the Lions Park Lilydale.



Engagement periods for the Lions Park Lilydale were undertaken (22 October 2021-14 November 2021)



Forum with key stakeholders, including a community group



190 page views of the Shaping Yarra Ranges, Lions Park Lilydale from 95 unique visitors



28 contributions through the Shaping Yarra Ranges, Lions Park Lilydale web page



Visitors came from: Direct to Shaping Yarra Ranges (55%); Yarra Ranges Website (17%); Search Engines (11%); and Other Sources (11%) and Social Media Channels (6%);

### What we heard


Community feedback was generally supportive of the redevelopment. With many of the submissions recognising the key issues and opportunities available in Lions Park, while providing direct commentary in response to the proposed design ideas.

The Draft Lions Park Redevlopment Master Plan undertook a wide ranging and consultation and engagement process through avenues such as: a key stakeholder forum & Shaping Yarra Ranges webpage.

Of the comments received in total 28 contributions, 61% provided commentary on the opportunities while 39% provided on the issues.

The comments vary and spread over the entuire areas. The data that has been captured provide an insight into the prioroties that community members have for Lions Park such as lighting, seating, entry signage/identification and rubbish bins. This Consultation and Engagement report provides a high-level summary of the most prominent feedback provided in response to the priority areas and actions proposed within Lions Park Redevelopment Master Plan. The feedback received will be used to inform some adjustments to the Master Plan.

The passion and pride of the community memebers were clearly evident in the submissions recieved, and will shape the design outcomes for this Master Plan.



# Design Priorities for Lions Park

Data insights captured through the Lions Park Lilydale website. Common themes / areas are shown below.



FEEDBACK - "ISSUES"		
Rubbish	Rubbish seem to be left in the park often. Potentially more bins can be provided and educate people for not leaving rubbish in outdoor.	
Eastern Bank	Weed infestation and concrete rubble on the eastern bank.	
	A concern was raised for providing boardwalk/path on the eastern bank as it might damage natural vegetation and habitat.	
Entry	Lack of clear park entry.	
	Need better entrances for both Lions Park and Recreation Reserve.
